ON A PERSONAL LEVEL, HOW HAVE THE ARTS IMPACTED YOUR LIFE, AND HOW DO YOU THINK YOUR EXPERIENCES SHAPE YOUR SUPPORT FOR THE NONPROFIT ARTS AND CULTURE SECTOR IN YOUR ROLE AS AN ELECTED OFFICIAL?

To increase access, I would advocate for more arts programming in schools, starting as early as elementary, to reach children who might not otherwise have exposure. Partnerships with local organizations and grants to support free or low-cost events and transportation to existing arts programs are also key strategies I would champion. Local government can play a pivotal role by creating dedicated funding streams for arts initiatives that don't pull from critical resources for housing or public services. Offering matching grants or tax incentives for organizations that engage underserved populations and contribute to workforce development can also help bridge the gap. Additionally, we can advocate for public-private partnerships to expand arts programming, leveraging community support without placing the entire financial burden on local government. By elevating the arts as an integral part of a thriving community, we can address these challenges and foster a more well-rounded city.

I am a former dancer and dance teacher. I spent my formative years in high school and college dancing everything from modern, jazz, bellydance, hip hop, to even half time dance team. I loved the expression and outlet it created for my own life and for others.

I taught dance classes at Barking Legs Theater for many years, and loved seeing students find their voice and expression through dance. It was more than just a workout, it was a creative outlet. Some of my students were residents in the Dodds Ave area nearby, and seeing their faces light up during session was worth every minute spent with them. Whether you're dancing in your living room, at a club, or for performance, movement of the body like that is good for mental well being and for physical health.

WHAT ARE SOME OF YOUR FAVORITE ARTS AND CULTURAL EVENTS, PROJECTS, OR PROGRAMS THAT TAKE PLACE IN YOUR DISTRICT?

Many of the events that take place at Barking Legs Theatre are some of my favorite. From regular musicians, to jazz nights, to collaboration with other community groups I have grown up going to events at Barking legs and they are an honored institution in our community.

Additionally, while not limited to district 9. The public guerilla art by Art For All Peoples has brightened up the life of many streets in District 9 and even given me a good laugh.

HOW DO YOU PERCEIVE THE ROLE OF NONPROFIT ARTS AND CULTURE ORGANIZATIONS IN THE OVERALL DEVELOPMENT AND WELL-BEING OF OUR LOCAL COMMUNITY?

Arts are a fundamental good to the human soul. The less we listen to music, enjoy a play, watch a movie, admire a painting, dance with friends, read poetry the weaker our souls become. Modern capitalist society increasingly looks at these as leisure activities to be minimized, and instead to focus on building our net worth. This is hogwash. I want ours to be a community that drinks deeply from the cup of life that only the muses can provide. And I will do whatever I can to support it and non profit arts and culture are an important part of this

WHAT SPECIFIC POLICIES OR INITIATIVES HAVE YOU SUPPORTED, OR ARE YOU PLANNING TO SUPPORT, THAT WOULD STRENGTHEN THE NONPROFIT ARTS AND CULTURE SECTOR IN OUR AREA?

I think building new and expanding current programs of direct grants to musicians, artists, and arts organizations would be a fantastic way to spur on the development of our next generation of artists.

I also would love to collaborate with local art's industry workers, or their unions like IATSE on putting together public arts and performances.

IN YOUR VIEW, HOW DOES THE SUPPORT OF NONPROFIT ARTS AND CULTURE ORGANIZATIONS CONTRIBUTE TO LOCAL ECONOMIC DEVELOPMENT, INCLUDING JOB CREATION AND TOURISM? HOW DOES SUPPORT CONTRIBUTE TO ENHANCED QUALITY OF LIFE FOR RESIDENTS OF CHATTANOOGA - HAMILTON COUNTY?

From Riverbend, to Nightfall, to the Hunter Museum to more, arts and culture organizations are a huge aspect in Chattanooga's growing tourism industry which comprises an increasing percentage of Chattanooga Jobs.

As long as this stays balanced with the needs of Chattanooga locals, this can be a fantastic boon for creation of good jobs.

UNDERSERVED AND MARGINALIZED GROUPS OFTEN LACK ACCESS TO NONPROFIT ARTS AND CULTURAL ORGANIZATIONS. HOW WOULD YOU INCREASE OPPORTUNITIES TO ENSURE THAT ALL MEMBERS OF OUR COMMUNITY CAN ACCESS PROGRAMS?

Marginalized people simultaneously have less access to public art programs, and see themselves and their issues less often represented in art.

I think expanding funding for arts programs in our local community centers is one great way to serve these communities. But also reaching out to organizations representing these communities and collaborating with them is important.

Also focusing on Spanish language arts would be important for me.

WHAT DO YOU IDENTIFY AS THE PRIMARY CHALLENGES FACED BY NONPROFIT ARTS AND CULTURE ORGANIZATIONS, AND WHAT DO YOU THINK LOCAL GOVERNMENT CAN DO TO ADDRESS THESE CHALLENGES EFFECTIVELY?

While I dont claim to have a great knowledge on specifically the arts sector, I have worked in the non profit industry. And funding is always a primary issue. And I would make it a focus to collaborate with arts and culture organizations to pursue this funding either from the city government itself or connecting them with state and federal opportunities.

DO YOU BELIEVE THAT INCREASED FUNDING FOR NONPROFIT ARTS AND CULTURE ORGANIZATIONS CAN IMPACT THE VITALITY AND GROWTH OF OUR LOCAL COMMUNITY? WHAT SOURCES OF FUNDING DO YOU THINK ARE MOST CRITICAL?

I believe that increased funding for non profit arts and cultures organizations can be a great boon to the community.

I think direct expenditures are a worthwhile investment from the city. So I would focus on public funding. While private funding is an option, it often comes with stipulations and censorship. And I think public funding creates a unique opportunity to give all artists a chance to express themselves
